## Frequently Asked Questions

### What is Zythor?

Zythor is Ensystem II's brand of sulfuryl fluoride (SF).

### Who is Ensystem II?

Ensystem II is a division of Ensystem, Inc. Ensystem was formed in 1994 to develop products and market them directly to pest management professionals. Since 1994 Ensystem has expanded to provide products and services to over 3000 PMP's in over twenty countries.

### How long has Zythor been on the market and where has it been sold?

Zythor has been on the market since 2006. It is sold in California, Florida, Hawaii, Georgia, Tennessee, Louisiana, Texas, Arizona, Massachusetts and New Hampshire and has already been used to fumigate thousands of structures.

### Is there any difference between the sulfuryl fluoride in Zythor and the sulfuryl fluoride in other products?

No. Sulfuryl fluoride is an odorless, colorless and tasteless inorganic molecule (S<sub>0</sub>F<sub>2</sub>). There is no formulation process for SF like most liquid pesticides where they are combined with other ingredients such as surfactants and wetting agents. Sulfuryl fluoride is sulfuryl fluoride.

### How do the use requirements for Zythor compare with other SF products?

Dosages, bagging to prevent foods from exposure, length of exposure periods and the length of aeration periods are all the same.

### What is the Zythor Stewardship Program?

### What if something happens on a fumigation where Zythor has been used? What kind of backing can I expect?

**First**, remember that sulfuryl fluoride is a very chemically unreactive molecule. Therefore the potential for problems due to reactions between Zythor and anything left within any space into which it is released is very small. This is the key advantage of sulfuryl fluoride compared to other fumigants.

**Second**, Ensystem has been marketing structural pest control products for over 14 years. We have a reputation for actively and aggressively supporting the thousands of users of our products to the maximum extent possible. We have been and will be there when our customers need us.

**Third**, like many chemical companies, Ensystem insures its risk through its own insurance company. This means that Ensystem is able to closely monitor and carefully control the handling of any claims.
